



2012 FINKE DESERT RACE GRID MEMO CLUB GIRLS GUIDELINES FOR GRID GIRL APPLICANTS

1. The 2012 Finke Desert Race Grid Girls are organised by Finke Desert Race Incorporated.
2. The 2012 Finke Desert Race will be held over the weekend of 8th to 11th June 2012.
3. Closing date for Grid Girl applications is **Friday 24 February 2012**.
4. Interstate and overseas applicants are welcome to apply, however all costs associated with travel are the responsibility of the applicant.
5. Successful applicants will be required to attend **ALL** scheduled Grid Girl appearances and activities which include, but are not limited to, Grid Girl photo shoot, Media Launch, Bigscreen Feature Video, Scrutineering Night, Race Day One, Race Day Two and Presentation Night. Dates, times and locations will be confirmed to successful applicants at least two (2) weeks prior to the event/activity.
6. Each applicant must complete the Grid Girls application form (online or on paper), provide two photos by email – one a full body shot and the other a headshot (examples of the photos to be submitted are on the Grid Girls page of the Finke Desert Race website). Applicants must also undergo an interview that will be held at a date and time to be determined by the organisers at the Finke Desert Race office. Interstate applicants will be over the phone.
7. Grid Girl applications are open to females who are eighteen (18) years of age as of 17 May 2012.
8. All details submitted in the application form shall be deemed to be current. In the event of any change of such details, the applicant shall notify the organiser immediately.
9. The Grid Girl uniform is property of Finke Desert Race Incorporated and must be returned at the conclusion of the event. When wearing the uniform, successful applicants are required to take care; avoid contact with make-up products, hair products, cigarettes and basic elements that could cause any type of staining or damage.
10. All rings, earrings that are not uniform including bracelets, anklets, nose rings, tongue rings, lip rings, eyebrow rings, etc must be removed, unless consent to wear them has been given by the organisers.
11. If successful, you shall, at all times, comply with the organiser's requirements (whether oral or written) as to your appearance, attire and/or accessories. A failure to meet such requirements may result in dismissal.
12. The organiser reserves the right to replace any successful applicant on the grounds of undesirable conduct and/or appearance.
13. If successful, you will always exercise caution when giving out any personally identifiable information about yourself. You are highly advised against meeting up with any competitors/members of the public, whether alone or accompanied.
14. Successful applicants who fail to attend briefing and publicity sessions or other events Grid Girls are required to be present, shall be replaced if the reasons for such absence are found to be unacceptable and ample notice is not given.
15. Successful applicants agree that Finke Desert Race Incorporated shall have the exclusive right to take photographs, record or otherwise and reproduce all or any part of your appearances in connection with the 2012 Finke Desert Race. Such recording could be audio, audio-visual or in the form of photographs.
16. You shall not speak to the press or other media nor give any interviews or comments relating to the 2012 Finke Desert Race without the prior written or oral consent from the organisers.
17. There shall be no claims against the organiser or Finke Desert Race committee, in the event the 2012 Finke Desert Race is cancelled or postponed by circumstances beyond reasonable control.
